## **Frontiers in Exploration of the Critical Zone Workshop Frontiers in Soil Science Research Workshop**

Two workshops of importance to soil scientists were held during the past three months. "Frontiers in Exploration of the Critical Zone", a workshop sponsored by the National Science Foundation, was held at the University of Delaware (Newark) in October 2005. The "critical zone" is defined as all fluid, mineral, gaseous, and biotic components, from the outer envelope of vegetation down to the lower limits of groundwater, that support all life on Earth. The Critical Zone Exploration Network (CZEN) is a proposed network of people, sites, tools, and ideas to investigate processes within this critical zone. The "Frontiers in Soil Science Research" workshop was convened by the National Academies on December 12-14, 2005, in Washington, DC. Experts in soil science and associated disciplines addressed the emerging research opportunities in soil science and integration of the biological, physical, geological, and chemical sciences within soil science. Discussions centered on addressing the need for interdisciplinary research involving classical soil science sub-disciplines, namely soil chemistry, soil physics, soil biology, soil mineralogy, and pedology, and tackling major research needs through collaborative efforts both among soil scientists and with scientists in related disciplines. ### **Tarleton Participates in Chinese Academy of Sciences Agreement**

As the staple for most of the food and fiber we grow, most of us take for granted that soil holds the earth together, providing the major necessities for most life on the planet. David C. Weindorf, Ph.D., assistant professor of soil science, has had the opportunity to use his knowledge of soil and soil science to bond two countries.

Weindorf traveled to Nanjing, China, on May 13-21, 2005, at the invitation of the Institute of Soil Sciences, Chinese Academy of Sciences (ISSCAS). During his visit, Weindorf addressed the ISSCAS regarding the soils research he has conducted jointly between Tarleton State University (TSU) and the Texas Agricultural Experiment Station. Weindorf has been collaborating with ISSCAS on manuscripts for publication in peer-reviewed journals. Three are under active development and two others have been accepted for publication in *Soil Survey Horizons* and *Pedosphere*.

The visit resulted in a signed memorandum of agreement between TSU and ISSCAS to provide for future student and faculty exchange. Weindorf anticipates the ISSCAS will be sending a student to TSU to conduct research for one year, as well as a TSU student traveling to Nanjing for studies. They will have the chance to work with professionals from a different continent, experience new cultures, traditions and gain an appreciation first hand of strength in diversity."

The ISSCAS, which was founded in 1953, serves agricultural development and ecological and environmental protection in China. Their research focuses on soil resources and their management, soil fertility and its regulation, and the soil environment and health. The institute's research goals include providing a scientific basis for decision-making and functional techniques for guaranteeing food safety, for increasing soil productivity, and for improving environmental quality, while at the same time striving to be proactive in developing progressive concepts of soil science. Weindorf had the opportunity to tour the ISSCAS Soils Museum, the historical archive of the ISSCAS, and took part in a 200-km field tour to visit their field research station and lab facilities.
