# Minutes from the Professional Soil Scientists Association of Texas Annual Meeting February 3, 2021

Meeting conducted online, via Zoom. Meeting called to order at 7:13 p.m.

Online statistics: 33 attendees. Meeting duration: approximately 1-1/2 hours

Laurie Kiniry, PSSAT President, thanked everyone for attending.

Attendees introduced themselves

## <u>Treasurer's Report from Travis Waiser</u> - see pages 5-6 for balance sheets

- Good year for General Fund
- Scholarship Fund was slightly in the red generous donations from members keep this fund afloat. PayPal is a popular way to pay dues.
- The IRS paperwork for 2020 has already been filed.
- Budget is good for the following year because we're not having a meal nor renting a venue for this year's meeting.
- Dennis Brezina moved that the Budget be approved. Seconded by Wayne Gabriel. Approved by acclamation.

## Webmaster Report from Carlos Villarreal - see page 7 for copy of report

- Took over from Jon Brandt in June 2020
- Added several useful links and field tour guides
- Added the Soil Scientist Spotlight highlighting careers and providing insight for prospective soil scientists. Invited membership to participate.

## Minutes from the 2020 Meeting

- Last year's Annual Meeting minutes were published in September 2020 PSSAT Newsletter
- Wayne Gabriel moved that the minutes shown on the screen be approved. Charlie Pehl seconded the motion. 2020 Minutes approved by acclamation.

## Scholarship Committee Report from Amanda Bragg

There were three applicants this year, including an applicant from a university that's never participated before (The University of Texas Rio Grande Valley). This was one of the strongest groups of applicants we have received.



Jonathan Peters is this year's scholarship winner. He is an Army veteran and a junior at Texas Tech University - scheduled to graduate in December 2021. He is on the TTU President's Honor List.

Matt Siebecker commented that last year's scholarship winner, Cynthia Jordan, is now a soil science Master's student at Texas Tech University.

## **Ethics Committee Report from Wayne Gabriel**

- If the By-Laws changes are approved, this will be the last Ethics Committee report. The Ethics Committee duties will be covered by the Executive Council.
- Wayne doesn't think we've ever had an ethics issue brought before us, including this year. He has a negative report.

## Constitution and By-laws Committee Report from Jamey Douglass

- Changes proposed and published in January 2021 PSSAT Newsletter
- Some of the changes proposed, considering trend of dwindling membership:
  - o reduce standing committee number from seven to six committees
  - o reduce the number of members on committees
  - o staggering tenures on committees

Wayne Gabriel moved that the Constitution and By-Laws changes described by Jamey be approved. Ed Janak seconded the motion. Changes approved by acclamation.

Treasurer's Report was reviewed by the committee. No errors found or questions for Treasurer.


## Membership Committee Report from Travis/Carlos

- Laurie Kiniry mentioned that PSSAT's 40<sup>th</sup> anniversary is coming up next year and would like to have as many people as possible be part of it. Please encourage soil scientists to join PSSAT.

#### Public Relations and Education Committee

- Laurie mentioned there is a chair for each committee, except for this one asking for a volunteer.
- Jon Brandt mentioned he spoke with Nathan about having a "speaker's bureau" comprised by PSSAT
  members. What prompted this discussion is that several PSSAT members have given classes and
  been involved with the Texas Master Naturalist program and Master Gardeners. Laurie commented
  that would be a good thing for that committee to consider.
- Dennis Brezina volunteered to be the PR/Education Committee chairman.
- Sidney Paulson moved that Dennis Brezina be approved as PR/Ed Chairman. Jon Brandt seconded the motion. Vote by membership not required.

## Licensure Committee Report from Ed Janak - see page 8 for copy of his summary



- Ed summarized the report from the PSSAT Committee for TBPG Sunset Review (PCTSR)
- Discussed parts of §851.22 mentioning there is no waiver available for the Council of Soil Science Examination (CSSE) -Professional Practice
- Ed suggested that the Committee be disbanded.
- He was appointed to the Texas BPG in 2019. His tenure expires in 2025. Please contact him if you have any questions. There will be a seat for a soil scientist in 2025, since he will not be reapplying for reappointment.
- Wayne Gabriel asked about including the committee's report in the newsletter.

- Laurie commented that the document could be utilized by the PR/Ed Committee
- Susan Casby-Horton said the document is quite large difficult to include in the newsletter. Wayne said there might be some good excerpts to include.
- Committee transmitted the report to Carlos Villarreal (PSSAT President at the time). He forwarded it to the Sunset Committee. Issue tabled for five years and will consider again in the future.
- Laurie Kiniry asked if there was any more discussion about the Committee Report
- Jon Brandt suggested to Carlos that we just put the whole document on the website. It would be easier than trying to publish excerpts in the newsletter. Ed Janak concurred. 
Other than that, I appreciate Jon's guidance and encouragement this past year and I look forward to serving as the webmaster!

## **Licensure Committee Report**

### PSSAT Committee for TBPG Sunset Review

The Texas Board of Professional Geoscientists (TBPG) underwent the legislative sunset review process during 2017 and 2018. Pursuant to a request by proponents of TBPG's continued existence and function (i.e., the existence of the Professional Geoscientist license) for permission to include the PSSAT logo on the cover of a document explaining the "value of professional geoscience licensure protection of the public's health, safety and welfare in Texas," the PSSAT Committee for TBPG Sunset Review (PCTSR) was appointed by PSSAT President Chance Robinson following the 2017 PSSAT annual meeting. The PCTSR was charged with editing/updating a document produced in the early 2000s by proponents of the then-proposed Geoscientist Licensure Act. I had the honor of chairing the PCTSR, which is without a doubt the hardest working committee I've ever been part of: Kelly Attebury, Jon Brandt, Susan Casby-Horton and Paul Reynolds. We spent countless hours independently and many hours together on the phone, initially "refreshing" the old document and ultimately scrapping it in favor of focusing on the soil science discipline. Although it was a true group effort, Kelly and Jon stepped up to do the heaviest lifting, the result being an informative document that not only served its intended purpose, but which could be useful for other purposes for years to come - as I told the committee in an August 2018 thank you note, I believe it's a very well fleshed-out framework for promotional and educational use to explain who we are and what we do. We provided the finished product to then-President Carlos Villareal, who then provided it to the proponents.

Things did not look good for TBPG in the initial sunset committee reports, and many were surprised at the final outcome, continuation of the TBPG and our license until September 2025. As I understand, public input (which I assume includes our document as well as the comments offered in writing and at the 2018 public hearing) swayed the committee's decision considerably.

The next TBPG sunset review is at least a few years out, so I believe the PCTSR has fulfilled its purpose and it's time to put us out to pasture. However, as mentioned previously, I believe the document we generated has great potential for other uses. As such, I suggest tasking one of the standing committees or an ad hoc committee with exploring that potential.
